2 General Business

Outstanding Actions

- 2.1 Design and graphics for the Taxi and Minibus Totems is currently being finalised. Installation expected to be completed shortly. Taxi Company contact details will alternate, 1st and 2nd position on reverse sides of the totmes.

- 2.2 Proposed *changes to* CPV driver training considered. The Department are looking at mandatory practical CPV driver test and completion of stage 1 CPV training prior to the issue of a provisional ID card. Forum members discussed the practicalities and impacts that these changes could have on driver recruitment in Alice Springs. Current wait times for CPV driver training in Alice springs is approximately 8-12 weeks between training courses. DoT to discuss with both Taxi companies and PH operators. **Ongoing**
- 2.3 Copy of the updated Police CPV incident report form provided to ETS for inclusion into the Alice Springs CPV training program. **Completed.**
- **2.4** DoT are finalising the new Tourist Vehicle In-Service Maintenance Standards. DoT to distribute when available. **Ongoing.**
- 2.5 Transport Roadmap CPV Reform strategy. Industry Consultation dates are still being finalised and DoT will keep Forum members updated as things progress.

- 2.6 Police presence at Take-Away Alcohol Outlets Alice Springs Operators have advised that passenger demand has declined by around 25%. Industry advised that a slow decline in visitor numbers over the past 3 months and this combined with the withdrawal of Tiger Airways on 22 July will have a further impact on the industry. **Ongoing**
- 2.7 Ulysess Grand Parade information was distributed and impacts on the day were minimal. **Completed**

Other Business

- 3.1 New Network approvals and reporting requirements- Darwin CPV Compliance Officer Simon Gillam recently visited Alice Springs to meet with CPV Networks and advise of the new approval process and reporting requirements. Networks to forward applications and required documentation to the CPV unit for approval. Ongoing
- 3.2 Sub Taxi Exemptions A number of sub taxi-exemptions requests have been approved for Alice Springs to meet the increased demand for Taxi services during recent special events. **Noted**
- 3.3 CPV Enforcement CPV Inspectors from Darwin recently conducted a compliance and enforcement audit in Alice Springs. Areas of concern were Casino ranking and MPT tariff lights. **Noted**
- 3.4 Casino ranking Chair, Jason O'Brien and DoT officer to meet with Casino management in regards to proposed changes to the ranking arrangements at the front entrance to the Casino. The Casino has advised that carpark renovations to commence shortly and interim ranking arrangements will be in place for both Taxi and PH vehicles. DoT to advise members of the new arrangements. Ongoing
